ROBINSON HURON TREATY (RHT) UPDATE

November 19, 2024

Aundeck Omni Kaning First Nation (AOKFN) Chief and Council met and decided at the November 18, 2024, meeting that AOKFN will distribute \$\frac{\$50,000.00}{}\$ from the Robinson Huron Treaty (RHT) Trust to our AOKFN registered membership. Eligibility for this disbursement is to be registered as an AOKFN Band Member on or before \$\frac{\$eptember 9, 2024}{}\$.

With that being said, we are now ready to begin receiving AOKFN registered members RHT Contact, RHT Release, and EFT/Direct Deposit forms (posted on the AOKFN RHT Portal) for database entry as we will be direct depositing AOKFN's RHT disbursement on **Monday December 2**, 2024; with a cutoff date for all required documentation by **Thursday November 28**, 2024. This means that all eligible AOKFN registered members will need a Canadian bank account (international residing AOKFN registered members will need to open a Canadian bank account) to receive the RHT funds when that date is designated. Please note, no cheques/certified cheques will be made for this disbursement.

EFT/Direct Deposit forms can be emailed to Ryan Corbiere (corbierer@aokfn.com), or Gizelle McCulligh (mccullighg@aokfn.com); or dropped off in a sealed envelope at the AOKFN Band Administration office with the attention of Ryan Corbiere (Finance Manager), or Gizelle McCulligh (Trust Officer) beginning today November 19, 2024 (if your information has not changed from the August 9, 2024 distribution). If dropping off in person, the AOKFN Band Administration office hours are Monday to Friday, 8:30am to 4:00pm (notify reception to speak to Ryan or Gizelle). Regular mail-in option is also available if chosen, in which the mailing address to mail your EFT/Direct Deposit Form is: Aundeck Omni Kaning First Nation, c/o Ryan Corbiere, 13 Hill Street, Little Current, ON P0P 1K0 (*Please note that with the current Canada Post Strike, the mail-in option may delay your submission).
