## **AUNDECK OMNI KANING FIRST NATION RHT RELEASE UPDATE**

October 14, 2025

This Aundeck Omni Kaning First Nation (AOKFN) Robinson Huron Treaty (RHT) update is regarding the new AOKFN Membership RHT five (5) year disbursement model of our AOKFN RHT Trust to the AOKFN Membership.

The approved AOKFN RHT 5-year Disbursement Model will roll out as follows:

- To be eligible for this new AOKFN RHT 5-year Disbursement Model, you must be **alive** and be an **AOKFN Registered Band Member** by or as of **October 31, 2025**; you must also be **alive** each subsequent year thereafter to receive the ten-thousand-dollar (\$10,000.00) disbursement each of those years as of October 31<sup>st</sup> for each subsequent year commencing October 31, 2026, and so forth to October 31, 2029.
  - If **death** occurs prior to **October 31<sup>st</sup>** for any specific year (2026-2029), the \$10,000.00 disbursement for that specific year the deceased individual **will not** be entitled to receive the \$10,000.00 for that specific year.
  - If **death** occurs on or after **October 31<sup>st</sup>** for any specific year (2026-2029), the approved appointed Executor of the deceased Estate will need to complete the necessary AOKFN RHT Estates Form to apply towards the deceased individuals Estate for that specific year for the deceased individuals \$10,000.00.
  - If death occurs prior to the completion year (November 2029) of this AOKFN RHT 5-year model, the deceased individual will only be eligible for the monies up until that November of that specific year the deceased passes if alive post October 31<sup>st</sup> of that specific year.
- A new AOKFN RHT 5-year Disbursement Model PCD Form is required each year to be eligible to receive this new ten-thousand-dollar (\$10,000.00) per year for this five (5) year model for the next five (5) years ending November 2029 in which the first of the remaining four (4) ten-thousand dollar (\$10,000.00) AOKFN RHT PCD Forms will be available each year in September of each subsequent year beginning Tuesday September 1, 2026.
- The ten-thousand-dollar (\$10,000.00) disbursement dates for each year commencing after this Wednesday November 26, 2025, will occur on Wednesday November 25, 2026, Wednesday November 24, 2027, Wednesday November 29, 2028, and Wednesday November 28, 2029.
